A scale ticket will be provided to each driver once they exit the landfill. It is the responsibility of the Permit Holder to collect the scale tickets from their drivers/contract haulers. Invoices are issued semi-monthly or monthly (as indicated above) by BMS and will include a summary of the loads delivered to the landfill.
- If you require, BMS will provide detailed hauling summaries. Please indicate below if you require this summary and provide the name and email address for authorized recipients, as well as the frequency in which you would like to receive the report.
- Drivers are required to wear proper PPE while on site.
- A minimum of 24 hours notice is required prior to commencing hauling.
