#### **Policy Statement**

It is Beaver Municipal Solutions vision to ensure the safe disposal of waste and to enhance the quality of life for the people of Beaver County. Accumulation of litter in ditches along local highways is unsightly and a nuisance for our neighbours and community. Costs associated with cleaning these ditches are incurred by Beaver Municipal Solutions.

Failure to comply with this secure load policy may result in a minimum \$250 surcharge being applied at the discretion of the site operator to the load to offset cleanup costs. This policy will take effect January 1, 2016.

Beaver Municipal Solutions has adopted a policy that all loads entering and exiting our facilities, specifically the landfill site in Ryley and the Tofield, Lindbrook, Viking and Kinsella Transfer Stations must be secured to prevent waste and litter from blowing off transport vehicles onto roadways and into ditches.

#### Guidelines

- All loads shall be secured or tarped from the point of origin to prevent spilling or scattering of material during transport.
- 2. Vehicle and trailer end gates should be in the up or closed position so as to prevent spilling or blowing of material during transport.
- 3. Scale attendants may require customers to uncover loads to inspect the contents of the load.
- 4. Unsecured loads may be charged a minimum \$250 surcharge at the discretion of the site operator.
- 5. Refusal to pay the surcharge or if the site operator believes the contents to be unsafe to unload will result in the load being refused and a call made to the local authorities.
